ORDINANCE NO.: 2016-12

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF DADE CITY, FLORIDA AMENDING CHAPTER 86, ARTICLE II, BUSINESS TAX TO INCREASE FEES; AMENDING SECTION 86-42 TO INCREASE ALL BUSINESS TAX LICENSE FEES BY FIVE PERCENT; PROVIDING FOR REPEALER, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 205.0535, Florida Statutes, the City Commission previously adopted an occupational license reclassification and rate structure on July 29, 1995; and

WHEREAS, occupational license fees were subsequently renamed business tax license fees; and

WHEREAS, Section 205.0535(4), Florida Statutes, allows for occupational license rates to be increased by up to five percent (5%) every other year after initial adoption; and

WHEREAS, the City has not increased its business tax license fees since 2002; and

WHEREAS, the City Commission now wishes to increase its business tax license fees by five percent (5%).

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Dade City, Florida as follows:

SECTION 1. Section 86-42 General Rate Schedules, of the Dade City Code of Ordinances is hereby amended by increasing each business category by five percent (5%) as provided in Exhibit "A".

SECTION 2. In all other respects, the provisions of Chapter 86, Taxation, of the Dade City Code of Ordinances have not been amended or modified and remain in full force and effect.

SECTION 3. Repealer.

All provisions of the Dade City Code of Ordinances, as amended, and ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of any conflict.

SECTION 4. Severability.

It is declared to be the intent of the City Commission of the City of Dade City, Florida, that if any section, subsection, sentence, clause, or provision of this Ordinance shall be declared invalid, the remainder of this Ordinance shall be construed as not having contained said section, subsection, sentence, clause, or provision and shall not be affected by such holding.

SECTION 5. Effective Date.


This Ordinance shall take effect on October 1, 2016.
