**RESOLUTION NO. 2009-16**

**A RESOLUTION OF THE CITY COMMISSION OF  
THE CITY OF DADE CITY, FLORIDA  
TRANSMITTING THE ADOPTED SCHOOL  
CONCURRENCY ELEMENTS TO THE STATE  
LAND PLANNING AGENCY AND OTHER  
AGENCIES PURSUANT TO SECTION 163.3184,  
FLORIDA STATUTES.**

WHEREAS, the City Commission of the City of Dade City, Florida (hereinafter referred to as “City Commission”) previously prepared Amendments to the comprehensive plan pertaining to school concurrency (hereinafter referred to as the “Amendments”) pursuant to the provisions of Section 163.3184, Florida Statutes, and applicable administrative regulations; and

WHEREAS, on January 13, 2009, the City Commission, sitting as the Local Land Planning Agency (hereinafter referred to as the “LPA”), held duly noticed public hearings to consider transmittal of the proposed Amendments received comments from interested citizens; and

WHEREAS, on January 13, 2009, the City Commission adopted Resolution No.: 2008-0981 which approved the transmittal of the Amendments to the State Land Planning Agency and other agencies pursuant to Section 163.3184, Florida Statutes, for informal comments.

WHEREAS, the State Land Planning Agency provided comments and forwarded same to the City for review and response on April 10, 2009; and

WHEREAS, on May 12, 2009, the Local Planning Agency and the City Commission both held public hearings to discuss the state’s comments regarding the amendments and elicited public comment during those meetings; and

WHEREAS, at the conclusion of the public hearings on May 12, 2009, the City Commission adopted the Amendments.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Dade City, Florida in regular session duly assembled, as follows:

**Section 1. Incorporation of Findings of Fact and Conclusions of Law.**

The foregoing findings of fact and conclusions of law are hereby incorporated into and made a part of this resolution.

Section 2. Transmittal of Adopted Amendments to State Land Planning Agency and Certain Other Agencies.

The City Commission hereby approves the transmittal of the adopted Amendments hereto as "Exhibit A" and incorporated herein by reference. The City Commission also hereby directs the Community Development Director to transmit the adopted Amendments to the State Land Planning Agency and certain other agencies in accordance with Section 163.3184, Florida Statutes, and applicable administrative rules.

Section 3. Effective Date.

This resolution shall take effect immediately upon its adoption by the City Commission.
